5. Financial statements

The club has \$74k in the bank (\$10k is Bendigo Walks grant funding). The bank balance grew by \$3k last year with a "normal" event calendar and average deposit interest rates (excluding payment from OV for Aus Champs carnival in 2022). Accruing and sitting on funds should not be the purpose of an incorporated association.

As a club we have decided to self-insure our assets. The club undertook a review in May 2022 ascertaining the total replacement costs being in the order of \$40k. It would be a freak event which would require us to replace all the equipment at a single point of time. Worst case scenario, the trailer and all the SI gear is lost in an accident requiring immediate replacement which would be somewhere in the order of \$20k - so this would be the minimum amount to keep on hand - leaving say \$50k for developing and investing in our sport.

The club should have a financial policy defining the maximum amount of spend in any given year, perhaps up to 20% of the surplus funds (equates to \$10k in 2024). These funds should be invested in growing participation by providing fun, accessible events. To date we have

relied on volunteers to run these events along with other grant monies (park and street challenge as an example). We as a club need to become comfortable with paying people to organise and run new events targeting new demographics.
